THE CONDITIONS BELOW ARE AN INTEGRAL PART OF THIS CONTRACT.

1. Cancellation of this Contract shall require a minimum of 7 days notice or full payment will incur.
2. Client agrees to provide Performer with the following on the night of said performance:
 - a) a dance floor reasonably free of food, liquids, stones, or other debris
 - b) a CD player, capable of playing burned CDs, near the performance area
 - c) a private dressing area with mirror, if needed
 - d) a safe environment for Performer and the Performer's property
 - e) a formal introduction of Performer if requested
3. Client will notify host of the event and/or owner/manager of the venue of the expected entertainment.
4. Client shall be responsible for the provision of mains electricity in the performing area.
5. Payment is due via check or cash before said date of event. If Performer is to be paid on said date of event, payment must be paid upon Performer's arrival at venue, before performance has commenced.
6. In order to ensure timely subsequent performances later in the evening, Performer shall wait no more than 20 minutes past the arranged performance time before additional charges will be made to Client. This additional charge is \$20 for each additional 15 minutes.
7. Any recordings or photographs shall not be used for commercial purposes without written permission from Performer.
8. All deposits paid to Performer are non-refundable.
9. \$25 fee will be payable to Performer for any returned check.
10. Performer agrees that the fee is inclusive of all expenses, holiday entitlements, traveling expenses to and from the venue, and covers any payments whatsoever due to other members of the performing act.
11. No fee shall be payable to Performer for any day upon which this engagement shall be suspended by reason of Earthquake, Fire, National Mourning, Epidemic, War, Strikes, Lockout, or by reason of order of any Licensing or Public Authority.
12. If there is no live band, Performer will provide an appropriate CD to be played during the performance.
13. If there is a delay in Performer's arrival time, Performer will call the venue telephone number listed on page one of this contract to inform Client of the delay.
14. This contract is deemed acceptable and binding when one of two conditions occurs: a) It is signed and returned within 7 days; b) A verbal agreement is made within the prescribed 7 days and no written objection has been made within its period.
15. Performer accepts no responsibility for non-fulfillment of contract, but every safeguard is assured.
